

#### **WORKSHOP DESCRIPTION**

This workshop illustrates how sexual development is related to problematic relationship patterns and troubling behavior. Participants will come away with new insights into human development and also will learn specific ways of applying this information to clinical work with individuals and couples. Participants will be updated on some of the most recent advances in psychoanalytic research (i.e., neuroscience, attachment theory, dreams, and chaos theory) and will learn why these new findings are important to clinical work.

#### WHO SHOULD ATTEND

This workshop is designed for clinical psychologists, psychoanalysts, mental health counselors, marriage and family therapists, social workers, and graduate students in the mental health field.

#### DIRECTIONS

**From the north, east, or southeast on I-465:** Travel east or south on I-465 to I-65 (Exit 53A). Take I-65N one exit and head south on Keystone Avenue (Exit 107). Go to the third stoplight and turn right on Hanna Avenue. Once you pass State Street, you have reached the UIndy campus. Turn right (north) on Shelby Street. Take the first right turn into the parking lots. Consult the campus map for the location of campus visitor parking.

**From the West and Southwest on I-465:** Travel to Exit 2A (U.S. 31) and head north to Hanna Avenue (second stoplight). Turn right. Go to the second stoplight (Shelby Street). Turn left on Shelby and take the first right into the parking lots.

**From the North or South on I-65:** Take Exit 107, Keystone Avenue, and turn south. Go to the third stoplight and turn right on Hanna Avenue. Once you pass State Street, you have reached the UIndy campus. Turn right (north) on Shelby Street. Take the first right turn into the parking lots.
